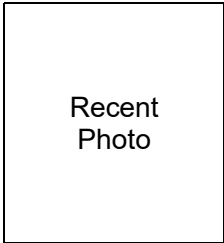

## Appendix A – Payment and Capping

### Monthly stipend allowance

1. The monthly stipend allowance will be credited to the successful applicant's bank account **after** the GIRO is successfully applied and established.
2. The bank account documentation must clearly show the bank account number in order to ensure that the GIRO application is smooth.

### Polytechnic tuition fee and other mandatory payables

1. Under the MCPT Study Award, successful applicants will receive polytechnic tuition fee coverage (cap at S\$1,650 per semester) after the necessary Tuition Grant and MOE Subsidies applied. Successful applicants who also receives bursaries for their polytechnic tuition shall not be entitled to further reimbursements unless the school fees is no longer covered by the bursary, grant or subsidy scheme.
2. Tax invoice provided by the polytechnic must be submitted together with the results from the last semester in order to process the necessary reimbursement.
3. Other payables indicated in the tax invoice that are not mandatory items will not be reimbursed.
4. Submission of documents for reimbursement must be within 3 months from payment date.
5. Treatment to the Polytechnic tuition fee and other mandatory payables as follows:
